SECTION 1: Identification of the substance/mixture and of the company/undertaking

1.1 Product identifier: Door Prep

1.2 Relevant identified uses: Professional cleaning and preparation solution for composite doors. For use only by Protect My Door technicians.

SECTION 2: Hazards identification

2.1 Classification under CLP:

Eye Irritation Category 2 – H319: Causes serious eye irritation.

Skin Irritation Category 2 – H315: Causes skin irritation.

2.2 Label elements:

Signal word: WARNING

Hazard statements:

- H319: Causes serious eye irritation.
- H315: Causes skin irritation.

Precautionary statements:

- P102: Keep out of reach of children.
- P264: Wash hands thoroughly after handling.
- P280: Wear protective gloves/eye protection.
- P302+P352: IF ON SKIN: Wash with plenty of water.
- P305+P351+P338: IF IN EYES: Rinse cautiously with water for several minutes.

Remove contact lenses if present and easy to do – continue rinsing.

- P337+P313: If eye irritation persists: Get medical advice/attention.
- P501: Dispose of contents/container in accordance with local regulations.

2.3 Other hazards: Not classified as PBT or vPvB.

SECTION 3: Composition/information on ingredients

Mixture: Proprietary blend of specialist cleaning agents and stabilisers.

Contains <5% non-ionic surfactants.

Full formulation withheld as trade secret.

SECTION 4: First aid measures

4.1 Description of first aid measures:

Inhalation: Move to fresh air if symptoms occur.

Skin contact: Wash thoroughly with water. Remove contaminated clothing.

Eye contact: Rinse cautiously with water for several minutes. Seek medical attention if irritation persists.

Ingestion: Rinse mouth. Do NOT induce vomiting. Seek medical attention.

4.2 Most important symptoms: Irritation to eyes and skin.

4.3 Medical attention: Symptomatic treatment.

SECTION 5: Firefighting measures

5.1 Extinguishing media: Water spray, foam, CO₂, dry powder.

5.2 Hazards: None unusual. Thermal decomposition may release irritating vapours.

5.3 Advice for firefighters: Wear standard protective equipment and SCBA if required.

SECTION 6: Accidental release measures

6.1 Personal precautions: Avoid contact with skin and eyes. Ventilate area.

6.2 Environmental precautions: Prevent entry into drains and waterways.

6.3 Methods for cleaning up: Absorb with inert material. Dispose in accordance with regulations.

SECTION 7: Handling and storage

7.1 Precautions for safe handling: For professional use only. Avoid contact with eyes and skin. Use only as directed.

7.2 Conditions for safe storage: Store in tightly closed original container in a cool, well-ventilated place. Protect from freezing and direct sunlight.

7.3 Specific use(s): Composite door surface preparation solution, applied only by trained PMD technicians.

8.1 Control parameters: No workplace exposure limits assigned.

8.2 Protective equipment:

Eye protection: Safety glasses recommended.

Skin protection: Protective gloves recommended during handling.

Respiratory protection: Not normally required.

Hygiene: Wash hands after use.

Appearance: Clear liquid

Colour: Colourless to pale

Odour: Mild, neutral

pH: ~6.0 – 7.5

Flash point: >60°C (non-flammable mixture)

Solubility: Fully miscible in water

Relative density: ~1.0 g/cm³

SECTION 10: Stability and reactivity

Stable under normal conditions of use and storage.

Avoid freezing and excessive heat.

SECTION 11: Toxicological information

Likely routes of exposure: Eyes, skin.

Effects: May cause irritation to eyes and skin.

No known chronic effects with normal professional use.

SECTION 12: Ecological information

Low environmental hazard under normal use.

Avoid uncontrolled release into waterways.

Biodegradable surfactant content in line with Detergent Regulation (EC) 648/2004.

SECTION 13: Disposal considerations

Dispose of contents/container in accordance with local regulations.
